HARVARD ENVIRONMENTAL LAW REVIEW Q&A FOR SCHOLARS

When and how do I submit an article?

HELR's submissions window is open twice a year. We publish two issues per year, and accept four articles per issue. Typically, the Issue 1 submissions window opens in August and the issue is published in April, and the Issue 2 submissions window opens in February and the issue is published in August. **HELR** accepts submissions on a rolling basis and leaves the window open until it selects the four pieces that will fill each Issue. Authors can submit their pieces during the submissions window either via Scholastica, or by emailing hlselrsubmit@gmail.com; HELR reviews Scholastica and email submissions equally. Authors will be notified when the submissions window is open and closed via Scholastica and HELR's X account (@HarvardELR).

How does HELR select which articles it publishes?

HELR reviews articles in multiple rounds.

The submissions committee, which is made up of HELR members, conducts a first-round review of submitted articles. The submissions committee reviews articles along several criteria and recommends whether the managing editors for submissions should advance the article to the next stage of review. The rubric that the committee fills out is attached.

In the second round of review, the managing editors for submissions review the rubrics and the articles. The managing editors fill out a similar rubric, and recommend whether the editors-inchief should advance the article to the next stage of review.

In the third round, the editors-in-chief review articles that have made it through the first two rounds of review. The editors-in-chief and the managing editors for submissions discuss which pieces they would like to extend an offer to. HELR does attempt to fill each issue with articles of various topics, but above all else, HELR values articles that are thorough, rigorous, well-supported, and BlueBooked correctly. Authors typically have a week to accept the publication offer. HELR receives many submissions, and so while we wish we could respond to each article submission, it is impossible to respond to each submission.

What does HELR look for in articles?

The attached rubric provides a useful, but not comprehensive, sense of the characteristics that HELR looks for in the articles it publishes. In general, HELR looks at the novelty of the article, the strength and accuracy of the source citations, the quality of writing, the potential impact of the article in addressing and resolving gaps in environmental law or policy. HELR gives preference to articles between 20,000-25,000 words.
